#### I. BACKGROUND:

The Community Advisory Committee is established pursuant to procedures outlined in the Special Education Local Plan for the Pasadena SELPA. Membership to this Committee includes individuals who are sensitive to and will work on behalf of students with disabilities (parents/guardians of students with disabilities, special education staff, general education staff, agency representatives, and community members) and responsible to the Board of Education and the Pasadena SELPA administration. The Community Advisory Committee responsibilities include advising the policy and administrative entity of the district, SELPA, or county office, regarding the development, amendment and review of the Local Plan.

### II. STAFF ANALYSIS:

The Community Advisory Committee members should be recommended based on these qualifications:

- The Community Advisory Committee should represent not only parents concerned with the quality of Special Education but the entire special education community.
- The Community Advisory Committee should be recommended by their peers.
- The Community Advisory Committee representatives must then be formally appointed by the local governing Board of Education (i.e. School Board).
- The Community Advisory Committee members shall be appointed by, and responsible to, the governing board of each participating district or county office, or any combination thereof participating in the Local Plan.
